WHAT IS THIS PRODUCT?

TYPE

Carmignac Portfolio China New Economy is a segregated sub-fund of Carmignac Portfolio SICAV, an investment company with variable capital regulated by Luxembourg law and qualifying as UCITS pursuant to Directive 2009/65/CE.

TERM

The SICAV was launched on 30/06/1999 for unlimited period. The sub-fund was launched on 31/03/2021.

OBJECTIVE

The objective of the sub-fund is to outperform its reference indicator, the MSCI CHINA INDEX (USD) index (Bloomberg code: NDEUCHF) over a recommended minimum investment horizon of 5 years. The sub-fund primarily invests in equities issued by companies or issuers that have their registered office or carry out a significant part of their business in the Greater China region, which includes Mainland China, Hong Kong, Macao, Taiwan and Singapore ("Greater China").

The sub-fund is managed on a discretionary basis with an investment strategy implemented through a portfolio of direct investments in Chinese equities. The investment strategy is applied without restriction in terms of allocation.

At least 75% of the sub-fund's assets will be directly or indirectly invested in equities issued by companies or issuers that have their registered office or carry out a significant part of their business in Greater China. The assets may also consist of fixed income securities, debt securities or money market instruments denominated in euro or other currencies as well as variable rate bonds. The sub-fund may use forwards traded on Eurozone and international markets, including emerging markets, for exposure or hedging purposes. The other derivatives liable to be used for hedging or exposure purposes are CFD (contracts for difference), OTC forwards, currency forwards, options (vanilla, barrier, binary) and swaps involving one or more underlying risks/instruments. The fund may invest in securities with embedded derivatives (in particular warrants, subscription certificates and P-Notes) traded on international regulated, organised or OTC markets. Investments in securities with embedded derivatives may not exceed 10% of the net assets. The sub-fund may invest up to 10% of its net assets in units or shares of investment funds. The sub-fund may also, on an ancillary basis, hold cash and/or invest in other transferable securities. The portfolio manager also reserves the right to invest up to 10% of the net assets in bonds with a rating below investment grade.

This sub-fund is an actively managed UCITS. An actively managed UCITS is one where the investment manager has discretion over the composition of its portfolio, subject to the stated

investment objectives and policy. This sub-fund is actively managed in reference to its Reference indicator calculated with net dividends reinvested. The sub-fund's investment universe is at least partly derived from the Reference indicator in terms of allocation by region, sector or market capitalisation. The sub-fund's investment strategy is not dependent on the Reference indicator; therefore, the sub-fund's holdings and the weightings may substantially deviate from the composition of the Reference indicator. There is no limit set on the level of such deviation.

The sub-fund promotes environmental/social characteristics in accordance with Article 8 of the Sustainable Finance Disclosure Regulation ('SFDR') through best-in-universe and best-effort approaches, and an active engagement policy. Extra financial analysis leads to a reduction of at least 20% in the fund's investment universe via a negative filter excluding companies whose extra financial ratings reflect high risks. In addition, the fund aims to contribute to China's 2060 carbon neutrality target and is committed to reduce its carbon intensity by 5% per year (base rate: base rate 530.2 tCo2e/€million revenues as of 31 December 2021). The sub-fund's short positions are not subject to comprehensive ESG analysis. The sustainability risk of the sub-fund may differ from that of its reference indicator.

INTENDED RETAIL INVESTOR

This sub-fund is intended for private and institutional investors wishing to diversify their investments while benefiting from market opportunities through reactive asset management over a recommended investment period of more than 5 years, due to the sub-fund's exposure to the equity market.

The appropriate amount to invest in this fund depends on the personal situation of the investor, their knowledge of investment products and experience, their personal wealth, their cash requirements now and in the future, and their degree of risk aversion.

OTHER INFORMATION

Investments may be redeemed each business day on request. Subscription, redemption or conversion requests are centralised two days prior to Valuation day before 15:00 CET/CEST.

The Depositary of the sub-fund is BNP Paribas, Luxembourg branch.

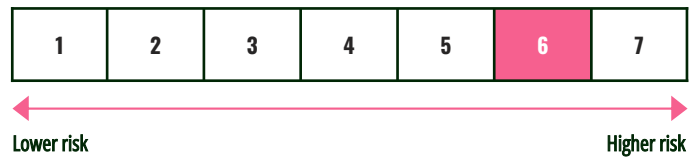

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator : the summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Risks to which the sub-fund may be exposed and which could lead to a fall in the net asset value to which the indicator gives too little consideration:

- Counterparty risk: the sub-fund may suffer losses if a counterparty defaults and is unable to meet its contractual obligations, especially in the case of derivatives traded OTC.
- Risks associated with China: investing in this sub-fund entails risks associated with China, especially risks associated with the use of Stock Connect (a system facilitating equity investment in the A shares market via a Hong Kong-based entity acting as the sub-fund's nominee). Investors are advised to familiarise themselves with the specific risks of this system, as well as with other risks linked to investments in China (CIBM, RQFII status...) as outlined in the prospectus.
- Liquidity risk: the markets in which the sub-fund participates may be subject to temporary illiquidity. These market distortions could have an impact on the pricing conditions under which the sub-fund may have to liquidate, initiate or modify its positions.



The length of the recommended holding period is 5 years.

If the sub-fund is denominated in a currency other than the applicable currency of the legal tender of the Member State where the PRIIP is being marketed, the return the retail investor gets, when expressed in the currency of the Member State where the PRIIP is being marketed, may change depending on currency fluctuations.

This product does not include any protection from future market performance so you could lose some or all of your investment.

We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the capacity of the fund to pay you.

WHAT HAPPENS IF CARMIGNAC GESTION LUXEMBOURG IS UNABLE TO PAY OUT?

For your protection, the assets of the fund are held with a separate entity, the custodian, so that the fund's ability to pay would not be affected by the insolvency of the management company. In the event of failure of the latter, the assets of the product held by the depositary will not be affected. In the event of default by the depositary, the risk of financial loss of the product is mitigated due to the legal segregation of the assets of the depositary from those of the product.

WHAT ARE THE COSTS?

Cost over time

The amounts shown here are the cumulative costs of the product itself, for two different holding periods. They include potential early exit penalties. The figures assume you invest 10 000,00 EUR. The figures are estimates and may change in the future.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Due to the sub-fund's exposure to the equity market, the recommended investment period is over 5 years.

However, you can redeem your investment without incurring any penalties at any point during this period, or stay invested for longer.

Redemptions are possible each business day. In exceptional circumstances, your right to request the redemption of your investment may be suspended.
